1762) To consider new planning applications

- a) CH/2015/1069/FA Stone Cottage, Parrotts Lane, Buckland Common, Buckinghamshire, HP23 6NX, Conversion of garage to habitable accommodation. It was agreed to reply "No Comment" to this planning application.
