#### 5229) To receive apologies for absence

5230) To approve the minutes of the Meeting of the Parish Council held on 23<sup>rd</sup> September 2019 and attend to matters arising not raised elsewhere on the agenda

#### 5231) To receive declarations of interest

Cllr Matthews declared an interest in the planning application PL/19/3250/FA.

#### 5232) Reports from County and District Councillors

Cllr Birchley reported the following:

- £500 had been given to the School out of the Community Leader Fund to re-build the tree cathedral at the School.
- Unitary Authority discussions continue. As well as a Chief Executive six members of the senior management team have now been appointed.
- GCSE results in the county are significantly higher than the national average

## 5233) To suspend standing orders and invite questions from members of the public

A number of members of the public asked questions to District Cllr Rose and the Councillors on the planning application PL/19/3250/FA - OS Field 4800, Cholesbury Lane, Buckland Common. A lengthy discussion took place on what constitutes grounds for objection under planning policy. Following a robust discussion all present acknowledged that whilst there were significant concerns regarding the intended use of the land that the parish council could only consider matters relating to the planning application in hand and its validity under planning policy.

#### 5234) Reports

(a) Chairman's Report and Questions to the Chairman

Cllr Brown had met with two District Councillor candidates and discussed current issues within the parish.

(b) Clerk's Report

The clerk circulated a provisional list of meeting dates for 2020-21. A finalised list will be circulated to Councillors for approval and then published on noticeboards and the website in due course.

(c) Local Area Forum (Cllr Brown)

Cllr Brown had attended the LAF meeting in the previous week. Nothing to report at this time.

(d) HS2 (Cllr Ingram)

The parish had submitted a written response to Dame Cheryl Gillan regarding the Oakervee review and had received an update on the HS2 discussions. Locally, felling of trees along the Link Road in Great Missenden had been halted due to consultation between protestors, Bucks County Council and HS2.

(e) <u>Luton Airport Expansion</u>

The consultation on the proposed plans for expansion of the airport is currently open. Councillors agreed to discuss this in more depth at the next meeting and draft a response to the consultation.

### 5235) Unitary Authority update, including:

(a) Shadow Authority Implementation Plan

This was covered under minute 5232, (second bullet point).

Cllr Brown advised 18 locations have been identified as council access points were residents can drop-in or make appointments to discuss roads, schools, council tax, etc. Chesham Library will be the nearest access point for residents in the parish.

- (e) To discuss changes to investment arrangements Cllr Brown had investigated alternative investment arrangements but unfortunately the parish council reserves did not meet the minimum amount required to invest. Reserves will remain in the Lloyds Bank savings account.

#### 5237) Policy Consultation - 5G Mobile Coverage In Rural Areas

Cllr Ingram updated Councillors on plans for 5G coverage in rural areas and highlighted:

- No Mobile Network Operator (MNO) has much concern for our parish coverage. Although the Dept of Culture Media and Sport is commissioning some studies on bringing 5G to rural areas, it cannot happen under present technologies.
- Ofcom proposes to subsidise pairs of MNOs to deliver 4G to rural not spots with a subsidy of £3-400m. In response the MNO's created the SRN Shared Rural Networks and got DCMS on board. New rural masts to be shared by all 4 mobile network operators. Contracts have been drafted but not yet signed. It was agreed the parish council should try to be included in the SRN coverage as do nearby rural parishes (Ballinger, Chartridge and The Lee). As soon as contracts are signed the parish council could initiate a broadband style campaign to ensure that rural village's needs are heard
