5261) Reports

(a) Chairman's Report and Questions to the Chairman

Cllr Brown reported on briefings he had attended on the Buckinghamshire Unitary Authority. Nearly all top tier appointments have been announced. Planning applications and enforcement matters will be dealt with by 5 Local Committees and officer teams, one based in Amersham. There will be 16 Community Boards including one based in Chesham where Parish /Town Councils and Buckinghamshire Council will decide on local priorities and spending decisions. 17 Community Access Centres, including one at Chesham Library for residents to talk directly with Bucks Council staff. A single contact telephone number and website will be launched for 1st April.

(b) Clerk's Report

The Clerk's report circulated prior to the meeting was noted.

The Clerk advised that Castle Water had not been collecting monthly direct debits due to their small amount and has decided to move to bi-annual invoicing. It was agreed a new bank mandate be completed to action revised payments.

Councillors noted that Chiltern DC Local Plan submitted comments and representations made in respect of the proposed plans had now been made available on the CDC website.

These complaints have been upheld and compensation has been awarded by the bank for the inconvenience caused. Cllr Brown suggested using this compensation money for suitable causes in the parish and asked councillors to consider possible purposes and community organisations as recipients. The parish council has now been registered for online banking allowing future payments of invoices to be paid via bank transfer.
