# The Chairman confirmed the meeting was being held under The Local Authorities (Coronavirus) (Meetings) Regulations 2020

- 5355) <u>To receive apologies for absence</u> Cllr Brackley and Buckinghamshire Councillor Mr N Rose sent their apologies
- 5356) <u>To approve the minutes of the meeting of the Parish Council held on 26<sup>th</sup> October 2020 and attend to matters arising not raised elsewhere on the agenda Approved and signed.</u>

#### Matters Arising

(a) Update on Gigabyte Broadband Project. Cllr Ingram to report Cllr Ingram reported a provisional submission was made to Openreach on 11th November. As three other

submissions related to the Cholesbury Exchange by communities outside this parish have also been made it is hoped this will maximise the cost saving and viability achievable under the Government's Rural Gigabit Voucher Scheme. Participation in the parish to date had reached 56% of eligible properties. Once provisional cost estimates per household are received a quick appeal for further registrations is to be made, a finalised residences list will be submitted.

#### 5357) To receive declarations of interest

Cllr Brown and Cllr Matthews declared an interest in planning application PL/20/3618/FA and withdrew from discussion on minute 5362a/(i)relating to this application. Cllr Ingram took the chair position for this item.

#### 5358) <u>Reports from Buckinghamshire Councillors</u> Cllr Birchley reported the funding sub-group of the Chesham and Villages Community Board have awarded a grant following the application by Hawridge and Cholesbury Cricket Club, sponsored by the Parish Council for funds toward equipment costs to expand community sport and exercise participation.

#### 5359) <u>To suspend standing orders and invite questions from members of the public</u> There were no questions asked by members of the public.

## 5360) Reports

(a) Chairman's Report and Questions to the Chairman

Cllr Brown reported on the Villages Forum meeting in October discussions over neighbourhood plans in the light of the withdrawal of the draft Chiltern Local Plan and development of a Buckinghamshire-wide Local plan. Also, that fly-tipping has increased in the surrounding parishes, particularly in The Lee and Pednor. Some common sites which are used for fly-tipping are been considered for CCTV. Cllr Brown asked Councillors to advise of any locations with fly-tipping problems.

(b) <u>Clerk's Report</u> The reimbursement for the purchase of the replacement arm for the Swan Lane cast iron signpost has now been submitted to Buckinghamshire Council as previously agreed. All allotment holders have been sent their annual allotment rental notice letter with a copy of the updated terms & conditions, which included guidance on the disposal of green waste and the use of compost bins. The clerk reported that 2.5 plots have become available at the allotments.
