The Meeting of the Parish Council took place on Monday, 26th July 2021 at 6pm

5439) <u>Reports from Buckinghamshire Councillors</u>

Cllr MacBean reported that TfB advised work had been undertaken to investigate and clear drains and gullies on Cholesbury Road. One gully has been cleared but the second drain gully etc need further investigation and has been escalated.

Buckinghamshire Council has been experiencing issues with waste collection, exasperated by the lorry driver shortage nationwide. A new fleet of waste vehicles are now in place, with more smaller vehicles to service the rural villages and it is hoped that waste services will return to normal operation.

Resurfacing work continues around the county, including in the parish.

5441) Reports

(a) Chairman's Report and Questions to the Chairman

Cllr Brown attended the recent Planning and Environment Forum on Tuesday,13 July 2021. The key message was that they are trying to improve on the processing of planning applications and enforcement issues. Staffing has been increased, including in the enforcement team.

Notification of planning applications was discussed at length and the current inconsistencies over who would be notified in relation to the location of an application.

Cllr Brown also reported on a Community Board meeting with the focus of the meeting being on rejuvenation and regeneration of businesses and activities. At the Board meeting he presented on the importance of rural businesses providing local services and employment to the community. The Board agreed to consider how they can support these businesses and some training sessions will be made available for those who have started up new businesses to attend.

Update on Gigabyte Broadband Project

Cllr Ingram reported that in mid-July, the impasse between the DCMS and broadband infrastructure providers over new T&Cs was resolved. Openreach is yet to confirm when the Cholesbury Exchange project will resume and in the mean time the Council has asked for some revisions and fine-tuning to the costings.
