## 5556) Reports

(a) <u>Chairman's Report and Questions</u> Nothing specific to report

- (b) <u>Clerk's Report including:</u>

  - (ii) The Chairman thanked the clerk on the successful outcome of the internal audit. A significant amount of work goes into preparing documents and liaising with the auditors so councillors were pleased with the results.

## (c) Update on Broadband Project

Cllr Ingram reported that the promised date when customers can order an Ultrafast fibre connection was missed on the 12<sup>th</sup> June. Openreach advised that an the cause of the delay was unfinished work on the infrastructure or 'headend' at the fibre broadband exchange. In the meantime, the fibre installation remains underway. Openreach has stated that: "customers will be able to order their fibre services at the end of July".

### 5559) To consider matters relating to Highways and Rights of Way

(a) Review Highways and Rights of Way Schedule

The schedule has been updated.

The Chairman highlighted that following a complaint raised with Buckinghamshire Council there is some evidence of vision splay verge cutting having taken place in the parish.

- (b) To discuss and finalise sign cleaning across the parish
  - Councillors discussed and approved contracting Andy Devner to carry out sign cleaning in the parish in July. The Chairman has prepared a sign schedule and map which will be supplied to the contractor to work from. Councillors approved the cost of £450 for this work.
- (c) Other highways matters
  - (i) The Chairman highlighted the importance of reporting faults via Fix My Street (<a href="https://www.fixmystreet.com/">https://www.fixmystreet.com/</a>) on any road issues. The Chairman asked Councillors to notify him of any matters that are reported so that they can be added to the schedule.
  - (ii) Councillors noted a resident's enquiry concerning the 'adoption' of a path in St Leonards used by residents who had removed fences replaced by the landowner. Following discussion it was agreed that based on the information provided it was not appropriate for the Parish Council to take up this case. The Chairman would draft a response to the resident.

Councillors noted that P Matthews Agricultural Contractors had cut the grass on the wide elevated verge on the bend close to Gilberts Hill.

It was noted the Green at Buckland Common will be cut in July and Cllr Ingram will identify and mark up C dead trees that need felling.
