#### 5526) Reports

#### (a) Chairman's Report and Questions to the Chairman

At the recent meeting of the Chesham and Villages Community Board a presentation from the Commander based at Amersham Fire Station who is also responsible for Chesham Fire Station advised there had not been a dedicated officer in charge of the Chesham Fire Station which is operated using retained fire fighters for over a year.

The Chairman advised he had asked how any fire incident in the in Chesham or the local villages would be dealt with. The Commander said an officer at the Amersham station would co-ordinate with the Chesham Stations retained fire fighters. The Chairman and others at the meeting asked for a further update on developments to fill this post as it was felt that this left the parish more vulnerable if there was an urgent need for assistance from the local fire service.

# (b) Clerk's Report

The Parish Council has now responded to Buckinghamshire Council's Settlement Review of Towns and Parishes. The Chairman added the response included that it was vital there were policies protecting Conservation Areas, prevention of infilling in rural communities and the allocation of adequate provision for traveller and gypsy sites.

# (c) Broadband Update

Cllr Ingram reported that Openreach contractors were currently in Cholesbury Lane and Parrotts Lane doing what should be the finishing civil works and fibre installations, so that the remaining 110 premises can be offered an Ultrafast fibre connection in March. Unfortunately, Openreach cannot give any indication as to when the Taylors Lane project can be reactivated until they resolve funding issues with the government.

### 5527) Coronation of King Charles III – progress since last meeting

One enquiry has been made for support for a local event and the Clerk will ask for more details.

Cllr Brown has also been in contact with local community groups asking them if they want to put forward proposals to the Parish Council for which a grant might be available.

Cllrs Brown and Maury had been in co-ordinating a project to produce a commemorative mug. Cllr Maury had been in contact with the School about children producing designs for the mug. Cllr Brown had been talking with companies that could produce a commemorative mug.

Councillors discussed the possibility of planting one or more trees to commemorate the coronation. Cllr Matthews said he was willing to co-ordinate the building and lighting of a bonfire along the lines of in previous years.

The Clerk reported the Community Board had approved the Parish Council's application for a grant of £1350 which equates to 90% of the anticipated purchase and installation costs of a replacement defibrillator and cabinet at Cholesbury VH. The award letter had just been received. It was noted that despite the cost of the defib units increasing, WEL Medical had confirmed the original quoted purchase price of £1500 including £250 VAT. Accordingly, the Parish Council would contribute £150 towards the purchase and installation costs. Councillors approved placement of the order for a defibrillator and cabinet and payment of £1500 to WEL Medical. Cllr Ingram would make arrangements for installation. It was noted that the Community Board grant of £1350 will be received once the purchase, delivery and installation is confirmed to Buckinghamshire Council.
