5554) Reports from Buckinghamshire Councillors

Chesham and Villages Community Board Engagement Event and Proud of Bucks Awards is taking place on Thursday 27th April 2023 at Chesham Town Hall.

Sponsored by the Clare Foundation, the Community Board will be presenting Proud of Bucks Awards for Chesham and Villages.

Buckinghamshire Council will be issuing a statement on the condition of the roads in the County shortly. A letter has been sent from the County Council to government highlighting the issues with the roads, the high levels of traffic and often harsher weather conditions in the Chilterns in the winter resulting in more roads failing.

Cllr Matthews questioned whether the fact that many of the roads were in such a poor state of repair that they were in fact illegal. He specifically cautioned that it was only a matter of time before serious harm or death is caused to a road user on Sandpit Hill because vehicles cross to the wrong side to avoid deep water flooding in the dip.
