County Councillor Birchley gave a brief update on the initiatives taking place to support the elderly and children in Buckinghamshire.

(a) <u>Chairman's Report and Questions including power outages and dog incidents</u>

The power outages that have caused significant problems in the area now seem to have been resolved. Working with The Lee Parish Council and Great Missenden Parish Council, data was collected on where the power outages that were occurring and whether this was in the daytime/evening/night hours and this was fed back to the UK Power Networks. The problems was eventually identified as a water leak near a cable in Wendover. The power outages were not HS2 related.

A paragraph in the Hilltop news and on Grapevine has explained in more details what was the cause behind the outages.

The Chairman reported on the recent problems with a group of dogs in the area that had been reported to the police.
