5733) Reports

(a) Chairman's Report

Community Boards will change in April moving from 16 community boards down to just 8. There are real concerns that small rural parishes will be far removed from local communities now and need to have stronger connections. Ross Tackley will remain as our local community board manager. It is unclear at this time how much funding the community board will receive and how this will be distributed for a wider area.

Enforcement

The enforcement team has visited the site traveller site and made some observations and taken note of the problems brought by Cllr Ingram to Cllr Strachan. Issues revolve around soil that may be contaminated having been laid on top of hardstanding standing. Cllr Ingram stressed that this was now for the Environmental Agency to look into.

The Black Horse continues to be a concern with large, aggressive dog breeds on the property as well as an unapproved change of use. The enforcement teams have been notified.

(b) Clerk's Report

Councillors noted that the precept request was submitted before the end of January deadline.

Councillors approved the updated publication scheme, which will be updated on the website.

The Clerk explained the process for the up and coming May elections to councillors and circulated the application forms. Councillors noted that submission of the application forms needs to be done in person by the 2nd April 2025 at 4pm.

5736) To consider matters relating to Highways and Rights of Way

Cllr Birchley and Cllr Ingram drove round parish with the Local Area Technician and there were 6 items that were agreed would be dealt with in October. Unfortunately, nothing has been done since, which is disappointing.

Flooding in Parrots Lane and Sandpit Hill continues to be incomplete. Cllr Ingram is in receipt of a letter from Highways to say they will look at the legacy borehole to see if its blocked and preventing overflow capture. In their letter they have accepted that it might require a new bore hole.

Cllr MacBean agreed to contact the highway engineer to ensure that this is on track, as well as to highlight the issues on Parrots Lane requiring remedial work. Cllr McBean further added that the there is a programme to clear gullies in the area and will ask when this is likely to take place in the parish.

Cllr Baddon highlighted that ditch clearing needs to be looked at more broadly to address ongoing issues. This does not form part of our devolution agreement so Cllr MacBean agreed to look into this further.
