Cllr Kersting declared an interest in a planning application.

5742) Reports from Buckinghamshire Councillors

County Councillor Birchley gave updates regarding bridleway and roads issues in the parish.

Cllr Ingram highlighted that flooding on Parrots Lane is still a concern and that the Local Area Technician are aware of the problem. They had promised remedial work to be done in October, then promised again at the end of the year that this would be done in 6/8 weeks but still nothing has been done. This is very disappointing.

On behalf of the parish council, Cllr Ingram presented County Cllr Birchley with a gift to thank her for all her hard work and dedication over the years. Cllr Birchley is retiring from the council after many successful years supporting local communities.

5744) Reports

(a) Chairman's Report

Cllr Ingram updated councillors on matters relating to enforcement at the traveller site in the parish. Concerns have been raised about the topsoil that has been spread across the site, which is now being addressed by the Environment Agency.

Residents have raised concerns over the activities on 7-Acre Field, which are now being investigated.

The planning department have announced that they will no longer be publishing comments on planning applications on the portal. This raises questions on how any fictitious comments can be identified.

In the local press, Councillors noted that Matthews Brick Yard are in the process of applying to extract clay in the parish. They have identified two blocks and over the next 10 years they will extract 50,000 tonnes of clay. Plan is for this to be done over the summer months. A request was sent into County Council and they determined they didn't need to do an impact survey, which is a real concern to the local parish council. The footpath crossing the field will be split. There is a real need to extract clay but there is also a site in Arrewig Lane, which had permission to extract until 2017 and they are still doing this at present. Whilst the parish council recognised that this is an important local business providing much needed brickworks and employment, there is also concern over the impact on the land. The last site was restored to nature and it is likely the same requirement will be needed for this site. The parish council will continue to monitor the application.

Devolution funding agreement has been signed. Currently some verges that are the responsibility of the parish council are cut by local residents, to which we are grateful. Cllr Matthews agreed to cut the verges on the S-bend.

(b) Clerk's Report
